Sealed Bids for the construction of the ***SEWER AND WATER SYSTEM IMPROVEMENTS*** will be received by ***CITY OF DURANT***, located at ***253 MULBERRY STREET, DURANT, MS 39063***, until ***11:00 A.M.*** local time on ***FRIDAY, JUNE 22ND, 2018***, at which time the Bids received will be publicly opened and read aloud.

Work consists of the following: rehabilitation and/or replacement of 31,000 feet of 8" and 10" sewer line and manholes, replacement of existing meters with approximately 1,132 new meters and automated meter reading system, and approximately 1700 tons of Riprap for sewage lagoon levy revetment.
