

## INVITATION FOR BIDS

### DHUD FORMAT 4238-A

Separate sealed bids for the construction of **WASTEWATER FACILITIES IMPROVEMENTS REBID, CDBG NO. 1137-20-301-PF-01** will be received by the **TOWN OF PLANTERSVILLE** at Town Hall board room located at **2587 MAIN STREET, PLANTERSVILLE, MS 38862** until **THURSDAY, MARCH 31, 2022 at 10:00 A.M.** at which time all Bids will be publicly opened and read aloud.

The project consists of:

#### **BASE BID**

- 1,494 LF of 10" PVC gravity sewer line, 150 LF of 10" DIP gravity sewer line, manholes, one (1) service reconnection, 25 LF of 16" or 18" x 0.250" open-cut steel encasement, 50 SY bituminous resurfacing, 10 Tons stone riprap with geotextile fabric, erosion control, seeding and mulching, and any additional miscellaneous appurtenant items.
- Two (2) wastewater flow metering arrangements at existing pump stations including yard piping, valves and fittings, manhole and manhole steps, access cover, electrical work, and any additional miscellaneous appurtenant items.
- 2,500 Tons 200 lbs. stone riprap lagoon levee stabilization with geotextile fabric.
- 120 CY crushed stone resurfacing at lagoon access drive.
- Lagoon influent piping backflow prevention modifications.

#### **DEDUCTIVE ALTERNATES**

- Lagoon influent piping backflow prevention modifications.
- 120 CY crushed stone resurfacing at lagoon access drive.
- 340 LF of 10" PVC gravity sewer line, manholes, connection to existing manhole, 25 LF of 16" or 18" x 0.250" open-cut steel encasement, 50 SY bituminous resurfacing, erosion control, seeding and mulching, and any additional miscellaneous appurtenant items.
- Two (2) separate alternates including 500 Ton increments of 200 lbs stone riprap lagoon levee stabilization with geotextile fabric.

#### **ADDITIVE ALTERNATES**

- 8" MJ gate valve installed on existing PVC influent force main at lagoon.
- Camlock power assembly at old lagoon pump station.

Each bid must be submitted in a sealed envelope addressed to the **TOWN OF PLANTERSVILLE**, marked on the outside as **"BID FOR WASTEWATER FACILITIES IMPROVEMENTS REBID, CDBG NO. 1137-20-301-PF-01."** Any bid for a sum in excess of \$50,000.00 shall contain on the outside or exterior of the envelope of such bid the contractor's current certificate of responsibility number, and no bid shall be opened or considered unless such contractor's current certificate number appears on the outside or

exterior of the envelope or unless there appears a statement on the outside or exterior of such envelope to the effect that the bid enclosed does not exceed \$50,000.00.

Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by the Engineer.

A certified check or bank draft, payable to the order of the **"TOWN OF PLANTERSVILLE"** negotiable U.S. Government bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and an accepted Surety, in an amount equal to five percent (5%) of the total of the Bid shall be submitted with each bid. The successful bidder will be required to furnish a Payment Bond and Performance Bond each in the amount of 100 percent of the contract amount.

This project is financed by a Community Development Block Grant and is subject to the rules and regulations thereof.

The successful bidder must comply with Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. 1701u). CDBG regulations governing the grant require that, to the greatest extent feasible opportunities for contracting, subcontracting, training and employment arising in connection with this CDBG project will be extended to Section 3 businesses and Section 3 residents.

Minority and Woman Owned Business Enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities, equipment, material and/or supply needs.

The **TOWN OF PLANTERSVILLE** is an Equal Opportunity Employer, and hereby notifies all Bidders will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, sex, national origin, age, disability, sexual preference, marital or veteran status, or any other legally protected status in consideration for an award.

The successful bidder must comply with the Davis-Bacon Act which requires that all laborers and mechanics shall be paid at rates not less than those determined by the Department of Labor to be prevailing for the locality in which the project is located.

The Owner reserves the right to reject any or all bids or to waive any informality in the best interest of the Owner.

Bids may be held by the Owner for a period not to exceed 60 days from the date of the opening of Bids for the purpose of reviewing the bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
