Base Bid for the Town of Tremont includes a Lime Feeder and Appurtenances, 10" Inserting Valve & Box, 6" Inserting Valve & Box, 4" Inserting Valve & Box (Qty. 2), 3" Gate Valve & Box, and 2-1/2" Gate Valve & Box. Deductive Alternate 1 includes a 6" Inserting Valve & Box. Deductive Alternate 2 includes a 4" Inserting Valve & Box. Deductive Alternate 3 includes a 3" Gate Valve & Box.
