Separate and sealed bids for the construction of **FARMINGTON, WATER SYSTEM STORAGE IMPROVEMENTS ARPA CONTRACT 1 – ELEVATED STORAGE TANK, AGREEMENT NO.: ARWAI-G-0020003** will be received by the **FARMINGTON WATER ASSOCIATION** located at, **4100 COUNTY ROAD 200, CORINTH, MS 38834**, until **10:00 AM**, local time **THURSDAY, APRIL 4th, 2024** and then at said office publicly opened and read aloud.

The Project consists of constructing a 500,000-gallon multi-column elevated steel water tank with concrete foundations, approximately 300 linear feet of 14" zinc coated ductile iron water pipe, and 1,060 linear feet of 10" PVC waterline including but not limited to site earthwork, access road, yard piping, valves, fittings, fencing, SCADA, existing booster station SCADA modifications. Electrical service, miscellaneous electrical work, erosion control, and additional appurtenant items of work.

This procurement will be subject to all applicable sections of the Mississippi Code of 1972, Annotated, as they apply to local governments, in accordance with RWAIG Program Regulations.

A conditional or qualified Bid will not be accepted. Award will be made to the lowest or best responsible, responsive Bidder. The Owner reserves the right to waive any informality or to reject any or all Bids.
