The proposed project includes the following: 300 GPM Well (Oktoc Rd.) - The well includes yard piping, chemical feed systems, electrical, control system improvements, 100 Kw generator, and all appurtenances. 40 Horsepower Well Pump Replacement at Existing Well (Akins Rd.) – This well pump replacement includes pump, drop pipe, well head, yard piping, chemical feed systems, electrical, control system improvements, and all appurtenances.
