<u>General</u>

- 1. The Bid Date for this project has been revised to 1:00 PM, December 22, 2020.
- 2. Supplemental Information: The Pre-Bid Meeting Minutes and Sign-in sheet are included as an attachment to this Addendum.
- 3. Clarification: Davis Bacon Wages will <u>not</u> be required on this project.

Project Manual

- 4. General Revision: All references to the Bid Time and Date of 1:00 PM, December 18, 2020 shall be changed to <u>1:00 PM, December 22, 2020</u>.
- Page I-11, Item 22 Project Questions: Replace the deadline for questions of 5:00 PM, Local Time, on December 14, 2020 with the following: <u>5:00 PM, Local Time, December 18, 2020.</u>
- 6. General Revision: All references to mandatory attendance of the Pre-Bid Meeting shall be removed. Attendance of the Pre-Bid will <u>not</u> be a requirement to Bid on this project.
- 7. Bid Form: Replace page II-5 of the Project Manual with the enclosed Bid Form. The following are the changes to the Bid Form.
 - a. Changed Pay Item 02540-2 Riprap Check Dams (14 TN) to "Stone Filter Ring (2 EA). Stone Filter Rings shall be installed per the Storm Water Pollution Prevention Plan.
 - b. Added the following Alternate Bid Items:
 - i. Pay Item 02100-1A: Clearing and Grubbing (Alternate Grading Plan) 1 LS
 - ii. Pay Item 02270-1A: Seeding, Fertilizing, and Mulching (Alternate Grading Plan) 1 LS
- 8. Page II-7 Summary of Alternate Bid Items: Replace this page in its entirety with the attached revision.
- 9. Part 9 The attached Storm Water Pollution Prevention Plan (SWPPP) shall be inserted in the Project Manual. Contractor shall be responsible for installing and maintaining all erosion control measures within the KCS right-of-way and any additional measures required to prevent sediment from exiting the project site. Contractor shall also adhere to all inspection and report requirements required by this SWPPP.

Pre-Bid Meeting Minutes

The following summarizes the minutes of the Pre-Bid Meeting held on December 8, 2020 for the above-referenced project. Some items mentioned during the Pre-Bid which were only a restatement of the Bid Documents may or may not be included again within these minutes. A list of the attendees of this meeting is attached.

Steven Toombs of Foster Jones and Associates (Engineer) opened the meeting by welcoming everyone and giving a general description of the project. Mr. Toombs then proceeded with an overview of the Construction Plans and Project Manual. The following is a list of items covered during this overview:

- All work performed within the Kansas City Southern (KCS) right-of-way must be completed by a KCS approved contractor. (A list of KCS approved contractors is included on page I-9 of the Project Manual.)
- State law states that publicly funded projects cannot require mandatory Pre-Bid Meetings; therefore, this requirement will be removed from the advertisement in a forthcoming addendum.
- There are no known underground utilities along the KCS mainline. (Note: This does not relieve the Contractor from the obligation to perform MS 811 locate prior to beginning construction activities.)
- Ties plates with curve blocks are required throughout the limits of the twelve-degree curve.
- All work shall be contained with the Owner's property and the KCS right-of-way. Special care shall be taken by the Contractor to not disturb adjacent lands.
- All material on the KCS right-of-way from the ballast up will be provided by KCS. All KCS supplied materials will be delivered via truck, including ballast. Contractor will be responsible for unloading KCS supplied material if delivered after the Notice to Proceed is issued. Ballast needed for the turnout installation shall be stockpiled by Contractor.
- If a Bidder is not on the list of KCS approved contractors included in the Project Manual but would like to be approved by KCS, Bidder should notify Engineer as soon as possible so they can be considered for approval by KCS.
- Emailed bids will be accepted provided they are submitted as instructed in the Project Manual. A hard copy must follow the emailed bid and the hard copy must be postmarked prior to the bid time. Any bids not submitted correctly will be rejected.
- Questions for the project are due by 5:00 PM on December 14.
- Contract time is 90 consecutive calendar days.
- Liquidated damages for this project will be in the amount of \$1,000 per calendar day.
- Contractor is responsible for the removal and proper disposal of all waste material from the project site. This includes all excavated soils and all trees and vegetation produced by clearing and grubbing activities.
- KCS will provide 6 transition rails. 4 will be installed in the KCS mainline track (2 ahead of turnout and 2 behind turnout) and 2 will be installed approximately at the KCS right-of-way. Contractor will be responsible for the installation of these transition rails.

- Contractor shall inspect the roadbed prior beginning construction activities to confirm stability and is encouraged to perform a proper proof roll (see Geotechnical Report for standard proof roll process). Any damages to the roadbed due to Contractor's activities shall be repaired by Contractor at no additional cost to the Owner.
- Owner has prepaid KCS for a maximum of 30 days for railroad flagging services which are required when Contractor's work will foul or have the potential to foul the KCS mainline track. Contractor shall plan and execute the work as to not exceed these 30 days. Any flagging services required in excess to these 30 days shall be the responsibility of the Contractor.
- Contractor shall request a work window to install the turnout in the KCS mainline track. (See paragraph "M" on page V-7 of the Project Manual for details regarding this work window.) The Contractor will be responsible with supplying KCS with an hour-by-hour work schedule as well a work plan including equipment and manpower.
- Contractor will be responsible for obtaining a Right of Entry from KCS prior to beginning work within the KCS right-of-way. Specific instructions are provided in Part V-Attachment A of the Project Manual.
- Contractor will be responsible for completing and submitting to Engineer a Daily Report. An example Daily Report form is included in Part V-Attachment B of the Project Manual. Contractor may use their own format provided it contains all the information included in the example.
- A Pre-Construction meeting will be held with the successful Contractor prior to the start of construction activities on the project site. Progress meetings will be held every 30 days. Additional progress meetings may be held if the project falls behind schedule or if, in the opinion of the Owner or Engineer, conditions of the project warrant supplemental meetings.
- Project Identification Signs must be placed on the project per Part 01580-1 in Section 6 of the Project Manual.
- No payment will be made for stored materials.
- One of the prospective Bidders ask if Davis Bacon wages will be a requirement on this project. This will be clarified in a forthcoming addendum.

After the meeting, all attendees were invited to make a visit to the project site. The following items were discussed during this visit:

• If deemed necessary by Contractor, Contractor will be responsible for the construction of a switch pad. If this switch pad is constructed within the KCS right-of-way, it shall be constructed in such a manner than drainage along the KCS mainline track is maintained to the satisfaction of Engineer. Any temporary drainage pipes shall be removed following the installation of the turnout. All disturbed areas shall be regraded and stabilized to the satisfaction of the Engineer. No additional payment shall be made to Contractor for the construction of a switch pad.

• An Alternate Grading Plan will be included in a forthcoming addendum. The Alternate Grading Plan will modify the left ditch up to the 24" pipe at Station 3+10.89 and minimize the clearing, grubbing, and ditching required within the KCS right-of-way.

At the conclusion of the site visit, the meeting was adjourned.

SUMMARY OF ALTERNATE BID ITEMS

LEE COUNTY INDUSTRY TRACK PROJECT DIP GRANT #425 VERONA, MS

Alternate Bid Items listed on the Bid Form are intended to provide the OWNER with a unit price from the CONTRACTOR for items of work that may be added to or removed from the scope of the project if mutual agreement is reached between the CONTRACTOR and OWNER during the course of this project. The use of alternate bid items shall be at the discretion of the OWNER and will be considered during the bid evaluation process. In the event one or more of the alternate bid items are used, a corresponding Change Order will be issued to adjust the contract price accordingly. The following is a general description of the Alternate Bid Items:

Alternate Bid Items A1, A2, and A3:

If, in the sole opinion of OWNER, the existing subgrade soils within the KCS right-of-way cannot be stabilized and properly compacted by reasonable efforts made by CONTRACTOR, OWNER may elect to mitigate unstable soils by one or more of the following methods:


- 1. Over-excavating unstable soils and replacing them with subballast
- 2. Installing a layer of geogrid and/or a layer of geotextile fabric
- 3. A combination of 1 and 2

Alternate Bid Items 02100-1A and 02270-1A:


OWNER is considering an alternate grading plan for the portion of the project falling within the KCS rightof-way. If selected, the grading plan will significantly reduce the amount of clearing, grubbing, excess excavation, riprap, and seeding that is required. The following changes will be made to the Pay Items if the Alternate Grading Plan is selected:

- A. Pay Item 02100-1: Clearing and Grubbing (1 LS) will be replaced with Alternate Pay Item 02100-1A: Clearing and Grubbing (Alternate Grading Plan) (1 LS).
- B. Pay Item 02270-1: Seeding, Fertilizing, and Mulching (1 LS) will be replaced with Alternate Pay Item 02270-1A: Seeding, Fertilizing, and Mulching (1 LS).
- C. Base Bid quantities for Pay Item 02200-1: Excess Excavation and Pay Item 02274-1: Riprap will be adjusted accordingly. The following are the estimated changes to these bid items:


