Contract time shall be **120** consecutive calendar days from the effective date shown in the Notice to Proceed. Liquidated damages will be assessed in the amount of \$300 for each consecutive calendar day beyond the specified contract time.

Special Damages: In addition to the amounts provided for liquidated damages, expenses and other losses, Supplier, in the event of such default, shall pay to the Owner the actual costs, expenses and other losses reasonably incurred by Owner.

Proposals be submitted, sealed and deposited with the **City of Union**, Mississippi prior to the hour and date hereinbefore designated. No bidder may withdraw his bid within 90 days after the actual date of the opening thereof.

Each Bidder must submit upon request an attachment stating his qualifications to perform the work. The Statement of Qualifications shall list past projects of similar size and nature, a list of references with name and telephone number, a list of key personnel who will perform the work, and other information supporting the Bidder's qualifications.

Awarding public contracts to non-resident Bidders will be on the same basis as the non-resident Bidder's state awards contracts to Mississippi suppliers bidding under similar circumstances. In order to ensure that Mississippi's so-called Golden Rule is followed state law requires a non-resident bidder to attach to his bid a copy of his resident state's current laws pertaining to such state's treatment of non-resident suppliers.

Each Bidder must deposit with his proposal, a Bid Bond or Certified Check in an amount equal to five percent of his bid, payable to the **City of Union**, Mississippi, as bid security.

Bidders shall also submit a current financial statement, if requested, by the **City of Union**, Mississippi.
