**Do Not Fax Proposals.** Proposals will be received by The District at the address shown above until **4:00 PM CST, May 18, 2023**. If the vendor chooses the mail-in option, proposals must be mailed to the address above in time for delivery before the closing date or hand delivered.

- No bids may be withdrawn after the scheduled closing time for the receipt of bids for a period of 90 days. The owner reserves the right to reject any or all bids and to waive informalities.
- All mail-in bids must have "NASD 1:1 Technology Solution" written on the exterior of the sealed envelope.

### 2) **Reverse Auction Information**

The reverse auction for this RFP will be conducted on **May 19, 2023 from 12:00 PM - 12:30 PM**. Bidders can call in their bids during this time. They can call 662-534-1800 to place a bid. If a vendor has emailed a bid in, and they do not see it appear within 5 minutes of bidding, they should call 662-534-1800 to inquire. The email may have been routed to SPAM. It is the vendors responsibility to follow-up if they are not seeing their bid.

All mailed-in bids will be placed on the reverse auction website at 12P M on May 19, 2023. All subsequent bids will be added to the website as soon as they are received. All vendors will have access to the reverse auction website and can bid against their own mailed in bid if they choose to use the bidding methods in the paragraph above.

Vendors who show up in person can submit their bid in person and their in-person bid will immediately show on the reverse auction website.

### **1. Scope of Work, Professional Development, and Technical Specifications:**

1. Must provide Qty. (760) iPad 64GB(Model Number: A2602) (Part Number: (BT7H2LL/A)).
2. Must provide Qty.(760) factory services- USA – Asset tagging for iPads.
3. Must provide (2400) JAMF for IOS EDU+3 years.
4. Must provide (210) MacBook Air M2 256GB Midnight. (Model Number: A2681) (Part Number: MLYE3LL/A).
5. Must provide Qty.(210) factory services- USA – Asset tagging for MacBooks.
6. Must provide (210) JAMF for MacOS EDU+3 years.
7. Must provide warranties and professional services for all equipment.
8. Pricing must be good for up to 90 days.
9. Must provide a Tax-exempt dollar out lease.
10. Please provide an option for 4 equal payments (financing). Payments begin July of 2023 and continue for 3 additional years after in July 2024, July 2025, and July 2026.

Bids, unless otherwise specified, shall be net, including transportation and handling charges fully paid by the vendor. All prices must: (1) be shown clearly, (2) be firm prices and free of any escalator, and (3) include all applicable taxes. The New Albany School District will furnish a tax exemption letter for State and Federal taxes where applicable.

1. Overall quality of proposal.
2. Vendor's qualifications, knowledge, experience, past work and functionality of previous 1:1 installations.
3. References of at least three installations of similar size, complexity, infrastructure design and installation method as proposed.
4. Compatibility with existing infrastructure and technology plan.
5. Price of proposal.
