 - E. Project Description: The project consist of point repairs in existing sanitary sewer main, cured in place piping (CIPP) lining of existing sewer main, removal of existing sanitary sewer manholes and piping, and installation of new manholes and sanitary sewer main.

 - G. Bidders will be required to provide Bid security in the form of a Bid Bond of a sum no less than 5 percent of the Bid Amount.

 - I. Submit your offer on the Bid Form provided. Bidders may supplement this form as appropriate.
 - J. If Bids are mailed or hand delivered, then they must be contained in a sealed envelope marked on the outside with the project name. They must be on file as received or delivered by the time stated above to the address of the Owner stated above. Do not deliver Bids to the project address or the Engineer's address.

- K. Electronic Bid Submission will be accepted on this project. Online bids can be placed on the website of the Architect at www.mpdesigngroupplans.us. If Bids are electronically submitted, then a title page containing the same information as would occur on the front of a sealed envelope must be included and must be clearly indicated as such in the file name.
- L. Bids in excess of \$50,000.00 must be marked on the outside of the envelope with the contractor's Mississippi certificate of responsibility number as issued by the Mississippi Board of Contractors.
- M. Your offer will be required to be submitted under a condition of irrevocability for a period of 90 days after submission.
- N. The Owner reserves the right to accept or reject any or all offers.
- O. The Contractor shall adhere to all procurement requirements as per document 2 CFR 200 as a part of the project expected to be funded in whole or in part by anticipated funds from the Mississippi Municipality & County Water Infrastructure (MCWI) Grant Program with anticipated American Rescue Plan Act (ARPA) funds.
