NOTICE is hereby given that the City of Clinton, MS, Mississippi, will receive written sealed bids until the hour of **10:00 a.m.** local time on **Tuesday, April 11<sup>th</sup>, 2023**, at the office of the City of Clinton, MS located at 530 Brighton Park Drive, Clinton, MS 39056 for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Broadway/Springridge Sewer Repair**

The project includes for the **pipe bursting/replacement OR open cut replacement of approximately 60' of sanitary sewer**. The Contract Time will be **thirty (30)** consecutive calendar days, and the liquidated damages will be **\$200** per consecutive calendar day thereafter.
