NOTICE is hereby given that the Madison County Wastewater Authority, Mississippi, will receive written sealed bids until the hour of 1:00 pm local time on **Monday, September 25, 2023** at the office of the **Engineer, WGK, Inc.** located at 204 W. Leake St., Clinton, MS 39056 for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **CMIC #1 Pump Station Rehabilitation**.

A Pre-Bid Conference will be held at 9:00 am local time, on **Thursday, September 7, 2023**, at the Pump Station site located at 230 Old Jackson Rd., Gluckstadt, MS, 39110.

The project includes the **Repair of corrosion damage to concrete wetwell and installation of new piping materials**. The Contract Time will be **Sixty (60)** consecutive calendar days, and the liquidated damages will be **\$250** per consecutive calendar day thereafter.
