NOTICE is hereby given that the City of Clinton, Mississippi, will receive written sealed bids until the hour of **10:30 a.m.** local time on **April 9<sup>th</sup>, 2024**, at the office of the **City of Clinton located at Department of Finance and Administration, 530 Brighton Park Drive, Clinton, MS 39056** (601-924-5474) for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Quail Hollow Drive Culvert Replacement**.

A Pre-Bid Conference will be held at **10:00 a.m.** local time, on, **April 2<sup>nd</sup>, 2024**, at the office of the Engineer, **WGK, Inc., 204 W. Leake St., Clinton, MS 39060**.

The project includes the **Removal of deteriorated corrugated metal arch pipe and replacement with 10'x4' precast box culvert and stream bank erosion control**.
