This project will create a new Public Works compound to relocate the current operations for the City of Ocean Springs Public Works Department from its current location on Pine Drive to a new location off of Bienville Blvd, previously occupied by a concrete plant facility.

REQUIRED SERVICES: The selected consultant shall complete facilities design services in accordance with applicable state and federal laws, regulations, and procedures. Activities will include site planning and design to ensure compliance with all aspects of project design and implementation including construction oversight.

Proposals for this work will be reviewed and rated in accordance with the following rating factors/criteria:

- 1. **QUALIFICATIONS:** Knowledge and technical expertise in this and similar projects;
- 2. **EXPERIENCE**: With similar projects;
- 3. **CAPACITY FOR PERFORMANCE**: The capacity to complete the work in a proper and timely manner given the current workload and staff; and
- 4. **PERFORMANCE**: Past performance of the consultant.

All proposals will be rated based on the following rating system which will be used to determine the best/acceptable offeror:

- Qualifications 40 Points
- Experience 30 Points
- Capacity 20 Points
- Performance 10 Points

Proposals will be reviewed by a Selection Committee using the above selection criteria. A written contract will be awarded to the firm whose proposal is within the competitive range and determined by the committee to be the most advantageous to the City. The contract will include scope and extent of work and other essential requirements. The Mayor and Board of Aldermen of the City of Ocean Springs reserve the right to reject any and all proposals and to waive any irregularities or informalities in the proposal process.
