Electronic bids will be received until the date and time via electronic online submission through Central Bidding. Said bids will be opened and read aloud in the City Council Chambers on the Second Floor of City Hall.

Bids are related to new roadway construction and improvement of existing intersections and will include, but is not limited to grading, drainage, paving and erosion control. Also included in the project is an additive alternate for milling and overlay of existing surface of Coley Road at McCullough Blvd Intersection as indicated in the construction drawings.
