The Jackson County Airport Authority is seeking to enter into an architectural services contract. Sealed Statements of Qualifications will be received by the Airport Director of the Jackson County Airport Authority at 8301 Saracennia Road, Moss Point, Mississippi 39563 until August 23, 2023 at 2:00PM

The submittals may also be mailed to 8301 Saracennia Road, Moss Point, Mississippi 39563; however, must be received on or before the submittal deadline. Five (5) copies of each submittal must be included in each sealed envelope with the company name and the following statement clearly marked on the outside of the envelope: "Sealed Qualification to be opened for the Terminal Expansion Project." Any qualification submittal not complying with instructions in this request for qualifications will be rejected.

The selected firm shall serve as the consultant of record and provide professional services encompassing all project-related architectural design, cost estimating and related project management services required for the project and satisfy all environmental requirements, related to the scope of work as more fully described in the Request for Qualifications Information Packet.

Information packets will be located at 8301 Saracennia Road, Moss Point Mississippi 39563, Monday through Friday, 7:00 a.m. to 4:00 p.m. All firms should submit a list of their qualifications, experience, and capacity for performance as required by the Request for Qualifications. Firms must submit the name of the primary contact person and the person within the firm (if applicable) who shall be the Owner's contact and party primarily responsible for rendering services, if selected.

Any contract awarded under this solicitation may be paid for in whole or in part with grant funding from the Federal Aviation Administration (FAA) Bipartisan Infrastructure Law (BIL) Airport Terminals Program or Airport Improvement Program (AIP) grant, MDOT Multimodal Transportation Improvement Program grant, and other state or local funding. Any contract resulting from this solicitation will be subject to the terms and conditions of said funding award or other federal laws or regulations, as applicable. The State of Mississippi, the United States, or any of its departments, agencies or employees is not and will not be a party to this solicitation or any resulting contract.

The Jackson County Airport Authority, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252, 42 U.S.C. §§ 2000d to 2000d-4) and the Regulations, hereby notifies all firms submitting qualifications that it will affirmatively ensure that any contract entered into pursuant to this advertisement Disadvantaged Business Enterprises will be afforded full and fair opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration of an award.
