- Subgrantee must provide documentation of compliance with 2 CFR 200 requirements for M/WBE solicitation.
- Subgrantees must provide an electronic copy (pdf) of all proposals received.

### Targeted Solicitation of Professional Services to Target Outreach for MBE/WBE

Subgrantee must provide documentation of compliance with 2 CFR 200 requirements for M/WBE solicitation. The Subgrantee may comply with 2 CFR 200 requirements for M/WBE solicitation by completing one of the following two options [one or the other]:

Documentation of the outreach efforts, such as certified mail receipts or email, must be provided to confirm the targeted solicitation was completed correctly. Subgrantees should request and document a response from all solicited firms.

### **Proposal Ranking**

A sample ranking form is also provided for Rural Water Association (RWA) use. Each RWA should establish the minimum score (example – 60 points) that a complete proposal by an appropriately licensed provider should receive. This minimum score is to assist with ensuring an impartial technical evaluation was completed. Any score is allowed by each member, if provided justification for a score below the minimum score is agreed upon by the selection committee.
