1. Introduction: The Leake County School District is located in Carthage, MS 39051. School facilities consist of five school-wide Title I schools and one central office. The district has approximately 2,500 students. Leake County School District has an accountability rating of a “C.”

2. Goal and Purpose of RFQ/RFP: The district is requesting proposals/quotes for a Language Arts & Mathematics Instructional & Diagnostic Program and EL Platform. The Diagnostic and online lessons will be used for all students in grades K-6 for ELA and Mathematics. Select students will take the diagnostic and online lessons in both ELA and Math for grades 6-8 online lessons and be inclusive of a K-12 English Learner documentation platform. The product should also include learning paths for students with teacher resources. This program should be aligned/correlated to the Mississippi College and Career Readiness Standards. - * provides professional development as needed virtual, on-demand, or in-person
- * must have capability to link and sync with SAM.
