Separate and sealed bids or electronic bids for the construction of **CONTRACT B: WATER PRODUCTION WELL MSDH AGREEMENT NO. ARMAI-G-0410042** will be received by the **NORTH LEE COUNTY WATER ASSOCIATION** until **2:00 P.M., LOCAL TIME ON TUESDAY THE 7TH DAY OF MAY 2024** then publicly opened and read aloud. Sealed bids will be received until the designated date and time at the Cook Coggin Office located at 703 Crossover Road, Tupelo, MS 38801. Electronic bids will be received until the designated date and time via electronic online bid submission through www.cceplanroom.com.

The bid opening will be held at the Cook Coggin Engineers Office, 703 Crossover Road, Tupelo, MS 38801 at 2:00 P.M. local time May 7, 2024. Any bids delivered on the day of the bid opening should be hand delivered at Cook Coggin Engineers Office.

The Project consists of the installation of a 250gpm 12"x8" production well (approximately 530ft deep), site work, and all appurtenant items for project completion.

Neither the State of Mississippi, the Local Governments and Rural Water Systems Improvements Board, nor any of their employees is or will be a party to this invitation for bids or any resulting or related contracts. This procurement will be subject to all applicable sections of the Mississippi Code of 1972, Annotated, as they apply to local governments, in accordance with RWAIG Program Regulations.

No Bidder may withdraw his bid within 60 days after the actual date of the opening thereof.

Simultaneously with his delivery of the executed contract, the Contractor shall furnish surety bonds subject to the conditions provided in the Information for Bidders.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout.

Each Bidder is responsible for inspecting the site and for reading and being thoroughly familiar with the Contract Documents. The failure or omission of any Bidder to do any of the foregoing shall in no way relieve any Bidder from any obligation in respect to this Bid.

A conditional or qualified Bid will not be accepted. Award will be made to the lowest or best responsible, responsive Bidder.

The Owner reserves the right to waive any informality or to reject any or all Bids.
