### INVITATION FOR BIDS

Notice is hereby given that the Mississippi Department of Environmental Quality (MDEQ) is seeking sealed bids for the DUPONT TRACT ROAD REPAIR AND REPLACEMENT PROJECT (the Project). The Project requirements are detailed in the Contract Documents. The Project is administered by MDEQ and funded through the Mississippi Trustee Implementation Group Final Restoration Plan II/Environmental Assessment: Wetlands, Coastal, and Nearshore Habitats and Oysters (RP/II/EA). The Project includes the construction of approximately 12,000 linear feet of gravel roadway within an existing 25-foot-wide dirt right-of-way, repair roadway depressions, and repair/install concrete low water crossing structures within the Wolf River Coastal Preserve.
