The Mayor and Board of Aldermen of The City of Amory, Mississippi will receive separate sealed Bids for the **Lagoon Fencing, Contract No. 23-1616-39, Bid File No. 2024-17**. The work consists of: **6,952 linear feet of 54 inch wire fencing consisting of barbed wire over hog wire mesh with the use of 84" metal tee posts; three sets of 16 foot horizontal slat gates (two eight foot gates each); seventeen warning signs (Wastewater); clearing and grubbing as required with some fill; 64 feet of seven foot high chain link fence with anti-climb; and, one 4 foot wide pedestrian chain link gate.**

The **City of Amory** will receive Bids until **2:00 PM** local time, **May 16, 2024** at the **City Hall**, Amory, MS. Bids received after this time will not be accepted. Bids will be opened and **publicly** read aloud immediately after the specified closing time.
