SCOPE OF WORK:

Remove interior drywall and insulation until there is no sign of termite damage. Remove all the termite, rotted and fire damaged wood. Continue the removal past the end of termite trails to verify all termites have been removed. Remove all exterior sheathing and old lap board siding. Replace any sills or top plates that are rotted or termite damaged. Reframe windows for BHA supplied replacement windows. After framing treat all exposed wood with Bora Care. BHA must be present for this treatment to verify product and coverage. Replace old lap and black board sheathing with 15/32 wall sheathing. Retreat again with bora care on all sheathing edges. Windows must be installed per manufactures installation instructions. Contractor to supply materials for the vinyl siding, Soffit, and fascia. Materials to be like kind of adjacent buildings. (0.42)


Replace all HVAC duct and plenum and tie into existing unit. Any Electrical and Plumbing that needs to be moved and replaced due to the termite or water damaged is included in your bid. You will be required to re insulate the walls and ceilings. You will be required to install fire wall in attic between units. You will be required to install drywall, finish, prime and paint the drywall. Paint and primer materials will be provided. You are also responsible for installing BHA provided pre-hung doors and trim. Cabinets to be removed and reinstalled by contractor. New Laminate countertops to be provided by contractor. BHA to approve color before purchase. Cabinets can be stored at BHA warehouse. The work will require a permit and you will be responsible for city inspections and any code required update needed. You must secure the units and clean up the debris around the building daily.

Unforeseen issues and areas that have damages that were not visible during bid process will be handled through a negotiated change order.

The work will require a current Certificate of Responsibility (License Number) from Mississippi State Board of contractors.

Contract time is 90 calendar days from notice to proceed. \$75.00 a day liquidated damage.

Contractor receiving the award will be required to provide a Certificate of Insurance (COI) naming the Biloxi Housing Authority as additionally insured with General Liability, Auto Insurance and Workers Compensation of \$1,000,000 for each prior to receiving the Notice to Proceed.
