The **Louisville Housing Authority, Louisville, Mississippi**, is now accepting bids for, **2021 Siding Replacement at 29 Buildings at Project MS 079-003** at the Housing Authority Office at 16120 West Main Street, Louisville, MS, until **2:00 P.M.** local standard time on **Thursday, April 7, 2022** at which place and time all bids will be publicly opened and read aloud.

The bid must be accompanied by a certified check or bid bond in an amount not less than 5% of the Base Bid; the successful bidder will be required to furnish and pay for a satisfactory Performance Bond and a Payment Bond in the amount of 100% of the Contract.

All other methods of bidding, except telegraphic modifications, will be considered non-responsive. No modifications on exterior of envelope without proper signature. **NO EXCEPTIONS**

The work will be in one Prime Contract.

All bid envelopes shall contain, on the exterior side, the Contractor's Certificate of Responsibility number. **NO EXCEPTIONS**

No bidder may withdraw his bid within 45 days after the date set for the opening thereof, and each bidder must comply with the laws of the State of Mississippi and all local laws relative to the performance of said work.
