The **Housing Authority Of The City of Tupelo, MS**, Tupelo, MS will receive bids for their **"2023 Lead Base Paint & Asbestos Remediation At Project MS 077-003 Park Hill Village East for the Housing Authority Of The City Of Tupelo, MS"**. Bids from Contractors will be received at the Central Office of the Housing Authority at 701 South Canal Street, Tupelo MS, until **2:00 p.m., Wednesday, April 26, 2023**, at which time and place all bids will be publicly opened and read aloud.

Each bid must be submitted in duplicate on forms furnished by the Architect and must be accompanied by a certified check or bid bond in an amount not less than 5% of the Base Bid; the successful bidder will be required to furnish and pay for a satisfactory Performance Bond and a Payment Bond in the amount of 100% of the Contract.

The work will be bid in one Prime Contract:

All bid envelopes shall contain, on the exterior side, the Contractor's Certificate of Responsibility number.
NO EXCEPTIONS

All bids shall be written on the form provided and shall be sealed in an envelope. All other methods of bidding, except telegraphic modifications, will be considered non-responsive. No modifications on exterior of envelope without proper signature.

Attention is called to the provisions for equal employment opportunity, and payment of not less than the minimum salaries and wages as set forth in the Specifications must be paid on this project.

No bidder may withdraw his bid within 45 days after the date set for the opening thereof, and each bidder must comply with the laws of the State of Mississippi and all local laws relative to the performance of said work.

The Tupelo Housing Authority reserves the right to reject any and all bids or to waive any informalities in the bidding.
