



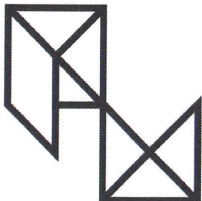

General Information

- Item No. 1. The bid date has changed. Sealed and electronic bids will be received at the Bureau of Building, Grounds and Real Property Management, 501 North West Street, Suite 1401 B, Jackson, Mississippi, 39201, until 2:00:00 p.m. on Tuesday, March 17, 2020.
- Item No. 2. Soils, concrete and quality assurance testing shall be by the Owner. Any additional testing outside of what has been noted above and required by the documents shall be by the Contractor (per Section 01410 – Testing Laboratory Services).
- Item No. 3. Refer to Sheet E2.1 and E3.1; low voltage wiring. The low voltage wiring for the lighting controls are not required to be in conduit except for the vertical runs from the wall mounted switch. The low voltage lighting control wiring can be secured to the conduit feeding the lights that it controls with zip ties secured every 18" (minimum) where applicable; otherwise, secure the wiring to structure with zip ties.

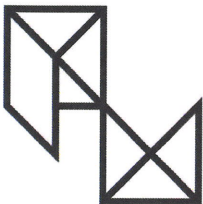

- Item No. 5. Refer to Sheet A3.2. All steel rigid frames and exposed metal roof purlins and wall girts shall be primed and painted.
- Item No. 6. Refer to Sheet A6.1; Door Hardware Schedule; Door 107. Replace Door Hardware Set No. 4, in lieu of Hardware Set No. 1 listed.
