

INVITATION FOR BIDS

Separate sealed bids for the construction of **WASTEWATER FACILITIES IMPROVEMENTS REBID, CDBG No. 1134-18-335-PF-01 & 1135-18-335-PF-01** will be received by the **CITY OF SHAW** at their **CITY HALL, 101 FAISON STREET, SHAW, MS 38773** until **THURSDAY, AUGUST 15TH, 2019 at 11:00 A.M.** at which times all Bids will be publicly opened and read aloud.

The project consists of improvements to both the Wastewater Treatment Facility (WWTF) and the Gravity Sewer Collection System. Improvements to the WWTF include the construction of the following:

Lagoon Floating Baffle
Site Earthwork
10" & 12" Ductile & PVC Yard Piping
Effluent Flow Monitoring
Chlorination/De-chlorination Basins
Chlorination/De-chlorination Equipment
Post Treatment Aeration Cascade
Reconstruct the Catwalk to Existing Outlet Structure

Improvements to the Gravity Sewer Collection System include the approximate quantities:

4" PVC Cleanout – 20 Each
4" PVC Service Line – 280 LF
Connection to Existing Service - 18

Each bid must be submitted in a sealed envelope addressed to the **CITY OF SHAW**, marked on the outside as **"WASTEWATER FACILITIES IMPROVEMENTS REBID."** Any bid for a sum in excess of \$50,000.00 shall contain on the outside or exterior of the envelope of such bid the contractor's current certificate of responsibility number, and no bid shall be

opened or considered unless such contractor's current certificate number appears on the outside or exterior of the envelope or unless there appears a statement on the outside or exterior of such envelope to the effect that the bid enclosed does not exceed \$50,000.00.

Contract Documents, including Drawings and Specifications, are on file at the **CITY OF SHAW, CITY HALL, 101 FAISON STREET, SHAW, MS 38773** and at the Office of Cook Coggin Engineers, Inc., 703 Crossover Road, Tupelo, Mississippi 38801.

Contract Documents are issued to potential Bidders only as paper copies from Plan House Printing and Graphics, 607 West Main Street, Tupelo, MS 38804. The non-refundable cost of the Bid Documents is \$150.00. Bidders may opt to purchase Contract Documents online at www.cceplanroom.com. All payments for Bid Documents shall be made payable to Plan House Printing and Graphics, 607 West Main Street, Tupelo, MS 38804.

Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by Plan House Printing, on behalf of the Engineer, and whose name appears on the official list of Planholders maintained by Plan House Printing.

A certified check or bank draft, payable to the order of the **"CITY OF SHAW"** negotiable U.S. Government bonds (at par value), or a satisfactory Bid Bond executed by the Bidder and an accepted Surety, in an amount equal to five percent (5%) of the total of the Bid shall be submitted with each bid. The successful bidder will be required to furnish a Payment Bond and Performance Bond each in the amount of 100 percent of the contract amount.

This project is financed by a Community Development Block Grant and is subject to the rules and regulations thereof.

The successful bidder must comply with Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. 1701u). CDBG regulations governing the grant require that, to the greatest extent feasible opportunities for contracting, subcontracting, training and employment arising in connection with this CDBG project will be extended to Section 3 businesses and Section 3 residents.

Minority and Woman Owned Business Enterprises are solicited to bid on this contract as prime contractors and are encouraged to make inquiries regarding potential subcontracting opportunities, equipment, material and/or supply needs.

The **CITY OF SHAW** is an Equal Opportunity Employer, and hereby notifies all Bidders will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, sex, national origin, age,

disability, sexual preference, marital or veteran status, or any other legally protected status in consideration for an award.

The successful bidder must comply with the Davis-Bacon Act which requires that all laborers and mechanics shall be paid at rates not less than those determined by the Department of Labor to be prevailing for the locality in which the project is located.

The Owner reserves the right to reject any or all bids or to waive any informality in the best interest of the Owner.

Bids may be held by the Owner for a period not to exceed 90 days from the date of the opening of Bids for the purpose of reviewing the bids and investigating the qualifications of Bidders, prior to awarding of the Contract.
