Separate sealed Bids for the construction of **Hayes Creek Water Association, Lodi System Improvements Contract 1, New 300 G.P.M. Water Well, Montgomery County, Mississippi, Project No. 110-16**, will be received by **Hayes Creek Water Association** at **the office of Hayes Creek Water Association, 703 Summit Street, Winona, MS 38967**, until **11:00 A.M.** (Local Time) on **December 3, 2019**, at which time the Bids received will be publicly opened and read. The Project consists of:

- Construction of a new 300 GPM water well
- Installation of a generator
- Treatment equipment, site work, fencing, electrical, and controls

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with alternate bid items as indicated in the Bid Form.

Prospective Bidders may examine the Bidding Documents at the Issuing Office **on Mondays through Thursdays between the hours of 7:00 A.M. & 5:00 P.M. and on Fridays between the hours of 7:00 A.M. & 12:00 P.M.**, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents also may be examined at **the office of Hayes Creek Water Association, 703 Summit Street, Winona, MS 38967, on Mondays through Fridays between the hours of 8:00 A.M. & 4:00 P.M.**

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of **\$150.00** for each set. **This is not refundable.** Checks for Bidding Documents shall be payable to "**Gardner Engineering, P.A.**". Upon request and receipt of the document fee indicated above plus a non-refundable shipping charge, the Issuing Office will transmit the Bidding Documents via **UPS**. The shipping charge amount will depend on the shipping method selected by the prospective Bidder. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

A pre-bid conference will not be held.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All bids submitted in excess of \$50,000 by a contractor to do erection, building, construction, repair, maintenance, or related work, on public projects must comply with Section 31-3-21, Mississippi Code of 1972, and must have a "Certificate of Responsibility" number. Where applicable, the foregoing certificate number must be indicated on the exterior of the sealed bid envelope before it can be opened.

Section 746 of Title VII of the Consolidated Appropriations Act of 2017 (Division A - Agriculture, Rural Development, Food and Drug Administration, and Related Agencies Appropriations Act, 2017) and

subsequent statutes mandating domestic preference applies an American Iron and Steel requirement to this project. All listed iron and steel products used in this project must be produced in the United States. The term "iron and steel products" means the following products made primarily of iron or steel: lined or unlined pipes and fittings, manhole covers and other municipal castings, hydrants, tanks, flanges, pipe clamps and restraints, valves, structural steel, reinforced precast concrete, and construction materials. The de minimis and minor components waiver apply to this contract.
