This project shall be constructed in accordance with the latest edition of the Mississippi Standard Specifications for State Aid Road and Bridge Construction.

PLANS AND PROPOSALS may be secured from Christian Gardner, County Engineer for Attala County, Mississippi, P.O. Box 1197, Kosciusko, Mississippi. The cost is \$50 for plans and \$50 for proposal, non refundable.

Certified check or bid bond for five percent (5%) of the total bid, made payable to Attala County and the State of Mississippi must accompany each proposal.
