The Warren County-Vicksburg Public Library Board of Trustees is requesting proposals from qualified Internet Service Provider (ISP) firms to provide eligible Internet services as defined by Schools and Libraries Division (SLD) of the Universal Services Administration Company (USAC). Interested ISPs must be registered with USAC and provide their Service Provider Identification Number (SPIN) and Service Provided Annual Certification (SPAC) in the cover letter of their proposals. Pursuant to USAC regulations, the Library has filed form 470, the 470/RFP number is 190007956. The certified 470 form is on file with USAC and the Library.

The project includes installation of data circuits, modem, router, fiber cable, gigabit switches and static IP addresses. Additionally, the proposal must include all costs with installation from the connection termination point to the Warren County-Vicksburg Public Library (WCVPL). WCVPL is seeking a single vendor turn-key solution for this project.

Services to be provided are professional services. The selection of the ISP is at the discretion of the Warren County-Vicksburg Public Library Board of Trustees and the Board reserves the right to refuse and reject any and all proposals submitted and to waive any or all formalities or technicalities. Evaluation of the proposals will include, but will not be limited to, items as follows:

- B. Prior Experience
- C. Ineligible cost factors
- D. Management capability
- E. Local Vendor

Written Proposals from those ISPs who do not attend the Mandatory Preproposal Conference will be disqualified.
