AMENDMENT # 1 TO  
MASTER PURCHASE AGREEMENT  
BETWEEN  
MNJ TECHNOLOGIES DIRECT, INC.  
AND  
MISSISSIPPI DEPARTMENT OF INFORMATION TECHNOLOGY SERVICES  
AS CONTRACTING AGENT FOR THE  
AGENCIES AND INSTITUTIONS OF THE STATE OF MISSISSIPPI  
(ORIGINAL PROJECT NUMBER 40730)**

This document (hereinafter referred to as "Amendment Number 1") shall serve to amend the original Master Purchase Agreement executed on June 18, 2015 (hereinafter referred to as "Master Agreement"), between MNJ Technologies Direct, Inc., an Illinois corporation having its principal place of business at 1025 Busch Parkway, Buffalo Grove, Illinois 60089 (hereinafter referred to as "Seller"), and the Mississippi Department of Information Technology Services having its principal place of business at 3771 Eastwood Drive, Jackson, Mississippi 39211 (hereinafter referred to as "ITS"), as contracting agent for the governmental agencies and educational institutions of the State of Mississippi (hereinafter referred to as "Purchaser"). ITS and Purchaser are sometimes collectively referred to herein as "State".

**NOW THEREFORE**, ITS, Purchaser, and Seller, by entering into this Amendment Number 1, mutually agree that the following provisions shall modify the aforementioned Master Agreement:

- 1) Article 1 under "Term of Agreement" shall be and hereby is amended so as to renew the Master Agreement for a period of one (1) year beginning July 1, 2017, and continuing through the close of business on June 30, 2018.
- 2) Article 41 "Transparency" shall be and hereby is revised by adding the following: "Notwithstanding the preceding, however, it is understood and agreed that pursuant to §25-61-9(7) of the Mississippi Code of 1972, as amended, the contract provisions specifying the commodities purchased or the services provided; the price to be paid; and the term of this Agreement shall not be deemed a trade secret or confidential commercial or financial information and shall thus not be redacted."

All other terms and conditions of the Master Agreement executed on June 18, 2015, shall remain unchanged and in full force and effect.
