NOTICE is hereby given that the Mayor and Board of Alderman of the City of Vicksburg, Mississippi will receive written sealed bids until the hour of **9:00 AM on Monday, March 19, 2018** at the office of the City Clerk of the City of Vicksburg, at the Vicksburg City Hall, 1401 Walnut St, Vicksburg, MS 39180, for the furnishing of all labor and materials and for the construction of that certain project designated as **"I-20 FRONTAGE ROAD SANITARY SEWER, WATER, AND GAS RELOCATION"**. Drawings and Specifications being on file at the office of the City Clerk at City Hall at Vicksburg, Mississippi.

The project consists of construction of: **approximately 3900 LF of 10-inch ductile iron water main, 1200 LF of ductile iron Sewer Line and 4700 LF of HDPE Gas Main along the U.S. Interstate 20 Frontage Road, with all related appurtenances shown on the Bid Form.** The total Contract Time will be 150 consecutive calendar days and the liquidated damages will be \$800 per consecutive calendar day thereafter.
