NOTICE is hereby given that the Mayor and Board of Aldermen of the City of Hazlehurst, Mississippi will receive bids until the hour of **10:00 AM local time, THURSDAY, AUGUST 16, 2018** for the furnishing of all labor and materials and for the construction of that certain project designated as "**Lake Hazle Dam Improvements, WEI # C016-070.000.**"

The project is located at the Lake Hazle Dam Spillway and consists of installing flowable fill under the existing spillway, repairing the existing concrete spillway, and providing embankment stabilization.

A pre-bid meeting will be held at Hazlehurst City Hall, 209 South Extension, Hazlehurst, MS on July 31, 2018 at 10:00 am.

Bidders shall submit their bids either in a sealed envelope or electronically. Sealed bids will be received at the office of the City Clerk of the City of Hazlehurst, Mississippi, at the Hazlehurst City Hall, 209 South Extension, Hazlehurst, Mississippi 39083. A view-only copy of the plans, specifications, and proposal documents are available at the Hazlehurst City Hall, office of the City Clerk. Electronic bids may be submitted in lieu of a sealed bid through www.waggonerengplans.com.
