The work is generally described as follows: Provide all labor and materials to rehabilitate and enclose an existing hangar. The project will include sandblasting and painting of the existing metal structure, framing and metal panels for new installation of hangar doors, insulation and installation of electrical systems.

Contract time is 120 calendar days. Liquidated damages in the amount of \$500.00 will be assessed for each consecutive calendar day after the contract time.

A pre-bid conference is planned for this project on June 2, 2020 at 11:00 AM in the Airport Conference Room. It is strongly recommended that prospective bidders attend the pre-bid conference.
