The Project consists of constructing **new water lines and appurtenances, system improvements at the Ginntown Treatment Plant site, Johnson Rd remote tank site, and Carto Booster Station site, new automatic read meter system installation, SCADA System improvements, and electrical/control improvements.**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis as indicated in the Bid Form.
