Sealed bids for the construction of Water System Improvements, Systemwide AMR Installation for the Town of Bude in Franklin County, Mississippi, will be received by The Honorable Linda Green, Mayor of the Town of Bude, until 2:30 PM local time on February 23, 2021, at the Bude Town Hall located at 125 W Railroad Ave, Bude, MS 39630, and shortly thereafter will be opened and publicly read.

The work involved in the project includes the replacement of the Town of Bude's existing water meters with new automatic read meters and associated hardware, software, and training as described in the construction drawings and specifications. A non-refundable deposit of \$100.00 is required at the time of request for Construction Drawings and Contract Documents. A copy of the Contract Drawings and Documents may be examined at the office of Dungan Engineering, P. A., 120 E Chickasaw St, Brookhaven, Mississippi 39601 during regular business hours.

A bid bond or certified check in the amount of 5% of the bid will be required. The bid bond or certified check will be returned immediately to unsuccessful bidders. Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposals will not be considered in making the award.

A performance bond, or equal, in the full amount of the contract will be required of the successful bidder. In lieu of a performance bond the successful bidder may post with the City of Columbia, Mississippi, the full amount of the bid, in cash or its equivalent, conditioned for the prompt, proper and efficient performance of the contract; said cash or its equivalent to be held until the successful completion of the project.

Attention is called to the fact that contracts exceeding \$50,000 require contractors to be licensed under applicable laws of the State of Mississippi and have a certificate of responsibility. The Town of Bude is an Equal Opportunity Employer, and hereby notifies all bidders will be afforded the full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, religion, sex, national origin, age, disability, sexual preference, marital or veteran status, or any other legally protected status in consideration for an award.
