Separate sealed bids for the **City of Greenville – Water Meter Replacement Project – Project No. 22-76E106** will be received by the City of Greenville, City Clerk's Office, 340 Main Street, Greenville, MS, 38701 until **11:00 am (CST), September 8, 2023** and then at said office publicly opened and read aloud. Bids will be tabulated and presented to the Greenville City Council at its next regular meeting.

The Project includes the following Work: Removal of existing AMI water metering system, including documentation, boxing, storing and transporting meters to the City's storage facility, and the installation of City furnished AMR water metering system throughout the City of Greenville's water service area.
