Sealed Bids or Electronic Bids will be received by the Board of Supervisors of Harrison County at the First Judicial Courthouse, Emergency Operations Center Conference Room, 1801 23rd Avenue, Gulfport, Mississippi, until 10:00 A.M., January 24, 2020, and shortly thereafter publicly opened, for the construction of 0.033 miles of Bridge and Approaches on Pete Hickman Road, in Harrison County, Mississippi, known as State Aid Project No. LSBP-24(15).

Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposal will not be considered in making the award.

All bids must be on file with the Clerk of this Board on or prior to the hour and date first mentioned above. Bids delivered in person must be delivered to the Chancery Clerk's Office in the First Judicial District Courthouse, Gulfport, Mississippi.

The Board of Supervisors hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color or national origin in consideration for an award.

The Board of Supervisors will meet at the time and in place first stated in this Notice and will then and there open, read aloud, consider and take action as the Board may determine on bids received in accordance with this Notice. The Board reserves the right to reject any and all bids and to waive informalities.
