Sealed Bids or Electronic Bids will be received by the Board of Supervisors of Harrison County at the First Judicial Courthouse, Emergency Operations Center Conference Room, 1801 23rd Avenue, Gulfport, Mississippi, until 10:00 A.M., February 28, 2020, and shortly thereafter publicly opened, for the construction of 0.028 miles of Bridge and Approaches on Clark Avenue, in Harrison County, Mississippi, known as State Aid Project No. STP/BR-0024(26)BO.

Bidders are hereby notified that any proposal accompanied by letters qualifying in any manner the condition under which the proposal is tendered will be considered an irregular bid and such proposal will not be considered in making the award.

The Board reserves the right to reject any and all bids and to waive informalities.
