ADVERTISEMENT FOR BIDS

Sealed Bids for the Pascagoula Sportsplex, Package 3 - Buildings project will be received by City of Pascagoula, at the at the Pascagoula City Hall, 603 Watts Avenue, Pascagoula, MS 39567 until 2:00 p.m., local time on March 12, 2019, at which time the Bids received will be publicly opened and read.

The Project consists of construction of two ground face concrete masonry block buildings with pre-engineered wood trusses. The scope of work includes, but is not limited to, standing seam metal roofing, cement board soffits/ceilings, acoustic lay-in ceilings, cast-in-place concrete slabs, chain link fencing gates, as well as ancillary plumbing, mechanical and electrical work and site lighting, and other related work.

Bids will be received from a single prime Contractor. Bids shall be on a lump sum basis as indicated in the Bid Form.

All bids shall be submitted in a sealed envelope addressed to the City Clerk of Pascagoula. If a bid is submitted by mail, the post office address of the City Clerk is P.O. Drawer 908, Pascagoula, Mississippi 39568-0908.

All bid envelopes should contain the bidder's name and mailing address on the face of the envelope and shall specify the name of the bid package.

This Issuing Office for the Bidding Documents is Brown, Mitchell & Alexander, Inc., 796 Vieux Marche, 2nd Floor, (228) 436-7612. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Monday through Thursday (between the hours of 7:30 A.M. and 5:30 P.M.) and Friday (between the hours of 8:00 A.M. and Noon). Copies of the Bidding Documents may be obtained from the Issuing Office as described below.

Bidding documents are being made available via paper copy or pdf for a charge of \$200.00 (hard copy) or \$100.00 (CD). Plan holders are required to log-in or register for an account at www.bmaprojects.com to view and order Bidding Documents. All plan holders are required to have a valid email address for registration. The cost for the bidding documents is non-refundable and must be purchased through the website. For questions regarding website registration and online orders please contact Plan House Printing at (228) 248-0181.

A pre-bid conference will be held at 10:00 a.m., local time on February 28, 2019 at Pascagoula City Hall, Council Chambers, 603 Watts Avenue, Pascagoula, MS 39567. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

When submitting an electronic bid, the bid must be submitted in "pdf" format and shall contain the same information and forms as required for the paper bids. Electronic bids must be secured with a bid bond. When submitting a bid electronically, the authorized signature shall be an electronic signature or handwritten in blue-ink signature. In the event that an electronically submitted bid has a corrupted attachment, the bid will be considered null and void. When bids

are submitted electronically, the requirement for including a certificate of responsibility, or a statement that the bid enclosed does not exceed Fifty Thousand Dollars (\$50,000.00), on the exterior of the bid envelope shall be deemed in compliance by including the same information as an attachment with the electronic bid submittal.

For an electronic bid, documents can be downloaded from Central Bidding or Plan House Printing. Electronic bids shall be submitted at www.centralbidding.com. For any questions relating to the electronic bidding process, please call Central Bidding at 225-810-4814.

The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda, if any, obtained from sources other than the Issuing Office.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the City of Pascagoula, as bid security. Bidders shall also submit a current financial statement, if requested by the City of Pascagoula. The successful bidder will be required to furnish a Performance Bond and a Payment Bond each in the amount of 100 hundred percent (100%) of the Contract amount.

For bids exceeding \$50,000.00, Bidder must indicate his <u>Certificate of Responsibility Number</u> on the outside of sealed proposal as required by Mississippi Law. Effective July 1, 2010; Per MS Code 31-3-21(3); any bid submitted by a nonresident contractor which does not include the nonresident contractor's current state law pertaining to such state's treatment of nonresident contractors, shall be rejected and not considered for award. If no such law exists in the nonresident contractor's state, then the non-resident contractor may provide a statement to that effect.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

The Owner reserves the right to waive any informalities or to reject any or all bids.
