A Pre-Bid Conference will be held at 10:00 am local time, on Monday, July 16, 2018 at the office of the Mississippi State Department of Health.

The project includes the **Water well abandonment**. The Contract Time will be **One Hundred Fifty (150)** consecutive calendar days, and the liquidated damages will be **\$300** per consecutive calendar day thereafter.
