President, 2nd Floor Accounting Department**, for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **RDC/WC Sewage Pumping Station Improvements**.

A Pre-Bid Conference will be held at **10:00 am** local time, on **Wednesday, March 6, 2019** at the 1450 County Farm Rd, Raymond, MS 39154 at pump station site.
