NOTICE is hereby given that the City of Brookhaven, Mississippi, will receive written sealed bids until the hour of 10:00 am local time on Thursday, April 11, 2019, at the office of the City of Brookhaven located at 301 S. First St., Brookhaven, MS 39602 (601-833-1414) for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Proposed Animal Shelter**.

A Pre-Bid Conference will be held at 10:00 local time, on Tuesday, April 2, 2019 at the office of the City of Brookhaven.

The project includes the **construction of a 40' x 50' animal shelter building with site work and utilities**. The Contract Time will be **Two Hundred Twenty (220)** consecutive calendar days, and the liquidated damages will be **\$350** per consecutive calendar day thereafter.
