NOTICE is hereby given that the Madison County Wastewater Authority, will receive written sealed bids until the hour of 2:00 PM local time on Friday, November 1, 2019, at the office of Bear Creek Water Association, 301 Distribution Drive, Madison, MS 39110 for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Bozeman Road Pump Station Improvements**.

A Pre-Bid Conference will be held at 10:30 AM local time, on October 22, 2019 at the office of the Madison County Wastewater Authority.

The project includes replacing submersible pumps, upgrading controls to VFD drivers, and other improvements. The Contract Time will be **Two Hundred Ten (210)** consecutive calendar days, and the liquidated damages will be **\$300** per consecutive calendar day thereafter.
