NOTICE is hereby given that the **City of Clinton, MS**, will receive written sealed bids until the hour of **10:00 a.m.** local time on **April 8th, 2020**, at the office of the **City of Clinton, MS** located at **530 Brighton Park Drive, Clinton, MS 39056 (601-924-5474)** for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Emergency Road and Bridge Repair on Cynthia Road being known as Project No. ERBR-25-049(01)**.

The project includes the **removal of an existing bridge, construction of a new precast concrete bridge and associated roadway improvements**. The Contract Time will be **one hundred (100)** working days, and the liquidated damages will be **\$300** per consecutive calendar day thereafter.
