The Mayor and Board of Alderman of Clinton, Mississippi, will receive bids for the 2018 Transportation Alternatives – Arrow Drive & Cynthia Road Multi Use Path – Federal Aid Project No. STP-0049-00(021)/LPA 107846-701000 no later than 10:00 A.M., Local Time, August 12th, 2020 at the Department of Finance and Administration of the City of Clinton located at 530 Brighton Park Dr., Clinton, MS 39056. All bids so received will be publicly opened and read aloud.

The work shall consist essentially of the following items:

Construction of asphalt paved multi use path along Arrow Drive and Cynthia Road

The above general outline of features of the work does not in any way limit the responsibility of the Contractor to perform all work and furnish all plant, labor, equipment and materials required by the specifications and the drawings referred to therein.

The attention of bidders is directed to the Contract Provisions governing selection and employment of labor. Minimum wage rates for Federal-Aid projects have been predetermined by the secretary of Labor and are subject to Public Law 87-581 Work Hours Act of 1962, as set forth in the Contract Provisions.

The award of this contract will be contingent upon the Contractor satisfying the DBE/WBE requirements.

Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to City of Clinton, MS as bid security. Bidders shall also submit a current financial statement, if requested by the City. The successful bidder will be required to furnish a

Performance Bond and a Payment Bond each in the amount of one hundred percent (100%) of the contract amount.

Bid submission shall be either paper or digital.

Paper copies of the proposal and contract documents shall be submitted in its entirety in a sealed envelope and deposited with the Department of Finance and Administration of the City of Clinton located at 530 Brighton Park Drive, Clinton, MS 39056 prior to the hour and date above designated.

All digital bids shall be submitted prior to the hour and date above designated.

No bidder may withdraw his bid within sixty (60) days after the date of actual bid opening, without Owner's consent.

Work to be performed shall be in accordance with the "Mississippi State Highway Standard Specifications for Road and Bridge Construction, 2017 Edition", together with all amendments and/or special provisions and/or addenda to the standards duly approved and adopted, unless otherwise noted in these specifications.
