NOTICE is hereby given that the City of Clinton, Mississippi, will receive written sealed bids until the hour of 10:00 AM local time on Tuesday, May 18, 2021 at the office of the City of Clinton located at Department of Finance & Administration, 530 Brighton Park Dr, Clinton, MS 39056 (601-924-5474) for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Section 592 Water System Improvements**.

A Pre-Bid Conference will be held at 1:00 PM local time, on Tuesday, May 4, 2021 at the office of the City of Clinton Public Works Department, 525 Springridge Rd., Clinton, MS.

The project includes the **Installation of C900 PVC water mains, valves, fire hydrants, steel casing, service line bores, service connections, connections to existing mains, and related appurtenances**. The Contract Time will be **One Hundred Twenty (120)** consecutive calendar days, and the liquidated damages will be **\$250** per consecutive calendar day thereafter.
