NOTICE is hereby given that the Fannin Water Association, Mississippi, will receive written sealed bids until the hour of 10:00 am, local time on Monday, September 27, 2021, at the office of the Fannin Water Association located at 2653 Highway 471, Brandon, MS 39042 (601-829-3343) for the furnishing of all labor and materials, and for performing all activities specified in the Contract Documents, for the construction of the **Northshore Landing Phase 4 Waterline**.

The project includes the **Installation of PVC waterline, fittings, valves, fire hydrants, steel casing and service assemblies**. The Contract Time will be **Forty-Five (45)** consecutive calendar days, and the liquidated damages will be **\$250** per consecutive calendar day thereafter.
