All bids so received will be publicly opened and the bid amount read aloud for the following project:

Bids must be submitted upon the standard forms contained within these contract documents furnished by Engineer, noted in the Information for Bidders. Each bid shall be accompanied by a Certified Check on a solvent bank or a Bidder's Bond issued by a Surety Company licensed to operate in the State of Mississippi, in the amount of five percent (5%) of the total bid price, payable to the City of Bay St. Louis as bid security. Bidders shall also submit a current financial statement, if requested by the City. The successful bidder will be required to furnish a Performance Bond and a Payment Bond each in the amount of one hundred percent (100%) of the contract amount.

The required bid documents shall be submitted in a sealed envelope and the outside of the envelope shall

be marked plainly as: Bay St. Louis Senior Citizen Center Hurricane Zeta Repairs Project and the Certificate of Responsibility Number.
