Sealed bids will be received until the designated date and time at the **PRENTISS COUNTY CHANCERY BUILDING, 100 N MAIN STREET, BOONEVILLE, MS 38829**. Electronic bids will be received until the designated date and time via electronic online bid submission through [www.cceplanroom.com](http://www.cceplanroom.com).

This project involves the **BASE, PAVE** and **STRIPE** of **COUNTY ROAD 1471** for approximately **0.325 MILES**.

**Bids will be accepted only under the name of the Bidder to whom contract documents have been issued by Plan House Printing, on behalf of the Engineer, and whose name appears on the official list of Planholders maintained by Plan House Printing.**

Each bidder must deposit with this bid, security in the amount, form and subject to the conditions provided in the Information for Bidders. For Bidders submitting bids electronically, the bond submitted must be either a bond issued by the Surety in electronic format or the original hard copy of the bid bond must be submitted to the **PRENTISS COUNTY BOARD OF SUPERVISORS, 100 N MAIN STREET, BOONEVILLE, MS 38829** prior to bid opening in order for the bid to be valid.

No Bidder may withdraw his bid within 60 days after the actual date of the opening thereof.

Simultaneously with his delivery of the executed contract, the Contractor shall furnish surety bonds subject to the conditions provided in the Information for Bidders.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over construction of the project shall apply to the contract throughout.

Each Bidder is responsible for inspecting the site and for reading and being thoroughly familiar with the Contract Documents. The failure or omission of any Bidder to do any of the foregoing shall in no way relieve any Bidder from any obligation in respect to this Bid.

A conditional or qualified Bid will not be accepted. Award will be made to the lowest or best responsible, responsive Bidder.

The Owner reserves the right to waive any informality or to reject any or all Bids.
