BID PRICES WILL BE F.O.B. TO THE NORTHEAST MISSISSIPPI REGIONAL WATER TREATMENT PLANT, 5590 HWY 178 WEST, FULTON, MS 38843. THE NORTHEAST MISSISSIPPI REGIONAL WATER SUPPLY DISTRICT RESERVES THE RIGHT TO ACCEPT ALTERNATE BIDS IN THE EVENT THE PRIMARY SUPPLIER IS UNABLE TO PROVIDE PRODUCT AS SPECIFIED.

AMMONIA MUST BE ANSI/NSF STANDARD 60 APPROVED. ALL VENDORS SHALL PROVIDE CERTIFICATE OF ANSI/NSF STANDARD 60 APPROVALS. THIS SHALL BE SUBMITTED WITH YOUR BID. THE BID SHALL BE ON A BULK BASIS AND MATERIAL SHALL MEET THE FOLLOWING SPECIFICATIONS:

1. ANHYDROUS AMMONIA

Refrigerant grade anhydrous ammonia or better and meet all AWWA standards for potable water application.
