THE NORTHEAST MISSISSIPPI REGIONAL WATER SUPPLY DISTRICT RESERVES THE RIGHT TO ACCEPT ALTERNATE BIDS IN THE EVENT THE PRIMARY SUPPLIER IS UNABLE TO PROVIDE PRODUCT AS SPECIFIED.

**AMMONIA** MUST BE ANSI/NSF STANDARD 60 APPROVED. ALL VENDORS SHALL PROVIDE CERTIFICATE OF ANSI/NSF STANDARD 60 APPROVALS. THIS SHALL BE SUBMITTED WITH YOUR BID. THE BID SHALL BE ON A BULK BASIS AND MATERIAL SHALL MEET THE FOLLOWING SPECIFICATIONS:

Refrigerant grade anhydrous ammonia or better and meet all AWWA standards for potable water application.
